*\* RIGHTS OF THE PUBLIC \**  
Office of the Attorney General Opinion LO-96-111

**A governmental body may give members of the public an opportunity to speak at a public meeting. If it does so, it may set reasonable time limits on the number, frequency and length of presentations before it, but it may not unfairly discriminate among speakers for or against a particular point of view.**

*\*SPEAKER TIME LIMIT FOR CITIZEN'S AGENDA\**  
Three (3) Minutes per Speaker

- D. **CITIZEN'S AGENDA:** In accordance with the Open Meetings Act, Council is prohibited from acting on or discussing (other than factual responses to specific questions) any items brought before them at this time. Per City of Krum Ordinance #0034-09-2006 each and every citizen who wishes to address the council shall be afforded three (3) minutes.
- E. **INTRODUCTION/SWEARING IN**
  - 1. Introduction and swearing in of the new Police Officer.
- F. **CONSENT AGENDA – None**
- G. **REGULAR AGENDA ITEMS**
  - 2. Hold a public hearing to receive community input on the FY 2016-2017 Proposed Budget.
  - 3. Discuss, consider and take action on an Ordinance adopting the 2016–2017 Budget and appropriating resources for the budget year beginning October 1, 2016.
  - 4. Discuss, consider and take action on an Ordinance levying and adopting the tax rate at a rate of \$0.647489 per one hundred dollars (\$100.00) assessed valuation on all taxable property within the corporate limits of the City for the 2016–2017 Fiscal Year.

5. Discuss, consider and take action on an Ordinance approving the 2016 Tax Rolls and accepting the anticipated collection rate of 100 percent for the fiscal year beginning October 1, 2016 and ending September 30, 2017.
6. Discuss, consider and take action on a vote to ratify the property tax increase reflected in the City's annual budget for Fiscal Year 2016–2017.
7. Discuss, consider and take action on an ORDINANCE TO INCREASE THE RATE OF DEPOSITS TO THE TEXAS MUNICIPAL RETIREMENT SYSTEM BY THE EMPLOYEES OF THE CITY OF KRUM.


