MINUTES

A. CALL TO ORDER

Mayor Ronald G. Harris, Jr. called the meeting to order at 6:31 p.m.

B. QUORUM PRESENT

Those present were Mayor Ronald G. Harris, Jr., Mayor Pro Tem Justin Diviney, Councilmembers Austin Petersen, Rhonda Harrison, Toby L. Lawrence and Mike Strand. Also present were Police Chief Terry Hargis; Finance Director Shelly Neckar; Public Works Director Devon Kennedy; City Planner Tom Elgin; Library Director Donna Pierce; Assistant City Attorney Trey Sargent; and City Secretary Andrea Dzioba.

C. INVOCATION/PLEDGE OF ALLEGIANCE

Mayor Ronald G. Harris, Jr. led the pledges to the United States Flag and the Texas Flag.

The invocation was given by Councilmember Mike Strand.

D. CITIZEN'S AGENDA: In accordance with the Open Meetings Act, Council is prohibited from acting on or discussing (other than factual responses to specific questions) any items brought before them at this time. Per City of Krum Ordinance #0034-09-2006 each and every citizen who wishes to address the council shall be afforded three (3) minutes.

Ms. Dianne Edmondson addressed the City Council and advised them that she was running for County Commissioner for Precinct 4 and requested their support in the May 22, 2018 Republican Primary Runoff.

E. PRESENTATION / DISCUSSION

Presentation – Children's Advocacy Center of Denton County – Troy Hamm

Mr. Troy Hamm made a presentation regarding the Children's Advocacy Center of Denton County and thanked the City of Krum for its continued support.

2. Presentation – Justin Diviney, City Council, recognition for years of service

Mayor Ronald G. Harris, Jr. presented a plaque to Justin Diviney and thanked him for his many years of service and dedication to the City of Krum.

3. Proclamation – "Motorcycle Safety and Awareness Month"

Mayor Ronald G. Harris, Jr. read the proclamation for "Motorcycle Safety and Awareness Month" and presented it to members from Denton Abate, Heathens MC, Iron Guardians, Honor Bound MC, and Local Riders.

4. Proclamation – "Police Week"

Mayor Ronald G. Harris, Jr. read the proclamation for "Police Week" and presented it to Police Chief Terry Hargis.

5. Proclamation – "Emergency Medical Services (EMS) Week"

Mayor Ronald G. Harris, Jr. read the proclamation and presented it to Firefighter-EMT Raquela Cornelius.

6. Mayor's Update

Mayor Ronald G. Harris, Jr. reminded the City Council about making sure that they return their budget questionnaires and about attending the public meeting with the Texas Department of Transportation. He also advised that included in their packets was project information from Freese and Nichols and that park surveys would be going out in utility bills to all of the residents.

7. Discussion – March 2018 Financials

Mayor Ronald G. Harris, Jr. opened the discussion item. Councilmember Harrison inquired about the Park expenditure and was advised that the Park General Fund account does help pay for our Park Maintenance Worker. Councilmember Strand asked why permit revenues were down and whether there was a way to tell exactly where we were short. City Planner Tom Elgin advised that there was no way to tell and it is also difficult to predict permit revenue as it is always a guess. Councilmember Strand inquired as to why there was a difference in the revenue between the Park Development Corporation and the Crime Control and Prevention District Funds. Finance Director Shelly Neckar advised that both areas are remitted separately by the State Comptroller's office and that there are different fees associated with the entities that are withheld. It does not end up being a completely equal split.

Discuss, consider, and take action on a request for approval of a Preliminary Plat of Brisa Meadows Addition for an approximate 9.5 acre tract of land located generally at the south end of Second Street, approximately 130 feet south of Jagoe Street, in Denton County, Texas, and known as Tracts 16 and 17 of the R.L. Lankford Survey, Abstract No. 733 and Lots 13-15, Block B of the Crain-Jones Addition and Lots 11 & 12 of the Crain-Jones Addition Section 2 in the Charles Despallier Survey, Abstract No. 370 and in the R.L. Lankford Survey, Abstract No. 733, Denton County, Texas. The existing zoning is Single Family-6 (SF-6) and Light Industrial (LI). The preliminary plat proposes 24 residential lots and 1 nonresidential lot. Owner: Brisa Properties. Applicant: Greg Edwards, GEES, Inc. Case: PPT-2018-01.

City Planner Tom Elgin provided information related to the request for approval of a Preliminary Plat of Brisa Meadows Addition. The property owner, Bradley Carrell, was available for any questions related to the Preliminary Plat. Discussion was held by the City Council.

Councilmember Strand made a motion to approve the Preliminary Plat of Brisa Meadows Addition subject to staff approval of the civil engineering plans, the entirety of the property being annexed into the City of Krum, and approval of applicable zoning for the proposed 24 SF-6 residential lots and one proposed LI non-residential lot with a second by Councilmembers Diviney and Harrison.

Gibbons Survey, Abstract No. 446, Denton County, Texas. The existing zoning is Planned Development-3-Single-Family Residential 7.5 (PD-3-SF-7.5). The final plat proposes 175 residential lots and six open space lots. Owners: Donna Ritz, Pamela Fowler Estes, and Freeman Family Living Trust. Applicant: Mark P. Allen, D.R. Horton. Case: FPT-2018-01.

City Planner Tom Elgin introduced the request for approval of a Final Plat of Fowler Farms Addition. Discussion was held by the City Council.

Police Chief Terry Hargis introduced the request for approval of a five (5) year contract with Axon Enterprise, Inc. for the purchase of five (5) new Taser units. He explained that the first payment in the amount of \$1,068.00would come from restricted funds for Training and Equipment and the remaining four payments of \$1,400.00 each could be drawn from the Crime Control and Prevention District Funds. Discussion was held by the City Council.

Councilmember Lawrence made a motion to approve a five (5) year contract with Axon Enterprise, Inc. for the purchase of five (5) new Taser units with a second by Councilmember Strand.
